THE SUPPLEMENTARY APPROPRIATION ACT, 2022

An Act to make supplementary appropriation out of the Consolidated Fund under Article 156(3) of the Constitution and Section 25 of the Public Finance Management Act, 2015 of a sum of one trillion, five hundred eighty three billion, four hundred twenty six million, fifty thousand, two hundred one shillings only to meet additional expenditure for the Financial Year 2018/19.

BE IT ENACTED by Parliament as follows:

1. Commencement

This Act shall be deemed to have come into force on the 1st day of July, 2018.

2. Supplementary appropriation.

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the Financial Year 2018/2019, for the purposes specified in column 1 of the Schedule to this Act, of the sums respectively specified in column 2 of the Schedule, is hereby allowed and confirmed.
